

INFORMATION FOR PHD STUDENTS WHO STARTED STUDIES BEFORE THE ACADEMIC YEAR 2019/2020

AND HAVE NOT STARTED THE OLD PROCEDURE

ABBREVIATIONS: RDN – The Council of Scientific Excellence
RND – The Academic Council Of Biological Sciences

If there is no other notations in the acts or resolutions, the wording regarding the deadlines (e.g. 7 days) refers to calendar days or months

A PhD student submits an application for the appointment of a promoter or promoters, or a promoter and an auxiliary promoter to the Chairman of the RND, to which the student encloses:

1) declaration from the proposed promoter or promoters or/and auxiliary promoter;
2) draft of the doctoral dissertation in printed version;
3) draft of the doctoral dissertation in electronic version;
4) PhD student's statement of compliance of both draft versions.

In addition, the PhD student encloses a statement about the language (Polish or English) in which the dissertation will be written.

The date of submitting the application is also the date of initiation of the doctoral degree procedure.

RND designates a promoter or promoters, or a promoter and an auxiliary promoter (max. 2 months).

The candidate submits ONLY attachments (WITHOUT THE APPLICATION!!!) to the Chairman of the RND, as to which details can be found in: § 12 ust. 2 Załącznik nr 1 do Uchwały nr 481 Senatu UW.

Short description of attachments:

- 1) doctoral dissertation (5 printed copies and electronic copy in PDF format);
- 2) positive opinion of the promoter or promoters regarding the doctoral dissertation;
- 3) statement in which the candidate declares a scientific discipline in which is applying for a doctoral degree;
- 4) scientific curriculum vitae;
- 5) copy of at least one publication;
- 6) *copy of the certificate or diploma confirming knowledge of a foreign language at a language level of at least B2;
- 7) copy of the diploma confirming that the candidate has a master's degree.

FURTHERMORE, the promoter or promoters provide the Chairman of the RND with a report confirming the dissertation verification using the Uniform Anti-Plagiarism System (signed by the promoter or promoters).

RND appoints an Examination Board (which doesn't include promoters!!!), which verifies whether the candidate has met the requirements referred to in: § 4 ust. 1 pkt 1-3 Załącznik nr 1 do Uchwały nr 481 Senatu UW.

[Legal basis: § 6 ust. 6 oraz § 17, § 18 Załącznik nr 1 do Uchwały nr 481 Senatu UW]

↓

The Examination Board after confirming that the candidate has:

- 1) title or diploma confirming that the candidate has a master's degree;
- 2) certificate or diploma confirming language proficiency at least at B2 level;
- 3) achievements (at least one publication);

4) positive opinion of the promoter or promoters about the doctoral dissertation;

conducts an exam confirming student's achievement of learning outcomes for qualifications at level 8 of the PRK in the discipline in which the student is applying for the doctoral degree (the date and place of the exams are announced at least 14 days before the exam).

After the examination, the Examination Board prepares a written opinion together with justification whether the candidate meets each of the requirements referred to in § 4 ust. 1 pkt 1-3 Załącznik nr 1 do uchwały nr 481 Senatu UW, and presents it to the RND.

After taking into account the opinion, RND decides by resolution to initiate or refuse* initiation of the doctoral degree procedure.

*It is possible to submit a complaint to the RND to the resolution on refusal within 7 days of its delivery.

RND decides by a resolution to maintain or revoke the refusal and initiate proceedings.

RND may appoint a Doctoral Commission (which includes the promoter or promoters) in order to carry out next steps in the proceedings of the doctoral degree.

The Doctoral Commission proposes candidates for 3 reviewers of the doctoral dissertation and RND appoints them.

[Legal basis: § 22 ust 1 pkt. 1 oraz § 23, § 24 Załącznik nr 1 do Uchwały nr 481 Senatu UW; Art. 190 Ustawa 2.0]

After appointing the reviewers, the RND Chairman delivers them a doctoral dissertation along with a report from the Uniform Anti-plagiarism System.

Reviewers prepare reviews within two months and forward them to the Chairman of the RND.

The reviews may contain one of three conclusions (with justification):

- 1) positive;
- 2) conditional (with tips on what to improve);
- 3) negative.

The chairman of the RND delivers reviews to the candidate after receiving them from all reviewers.

If one of the reviews has a conditional conclusion, then:

1. the candidate has 6 months to improve her/his doctoral dissertation and resubmit it;
2. then the dissertation goes back to all reviewers;
3. reviewers prepare new reviews with conclusions: positive or negative.

The chairman of the RND submits the final reviews of the dissertation to the Doctoral Committee.

After analyzing all reviews (positive or negative), the Doctoral Committee prepare a resolution:

- 1) decides to admit a candidate to defend a doctoral dissertation
(the requirement is at least two positive reviews and an absolute majority of votes);
- 2) requests the RND to refuse to allow the candidate to defend his doctoral dissertation*.

*Candidate can submit a complaint to the Council of Scientific Excellence within 7 days of its delivery
against the decision to refuse to allow the defense of a doctoral dissertation.

The University (max. 30 days before the day of defense of the doctoral dissertation) provides the doctoral dissertation with reviews in BIP.

The Doctoral Commission sets the date, time and place of defense of the doctoral dissertation.

The chairman of the RND immediately informs the candidate about the date, time and place of defense
and places an advertisement on the UW website.

The defense of the doctoral dissertation takes place during a meeting of the Doctoral Commission.

Any details can be found in: § 30 Załącznik nr 1 do Uchwały nr 481 Senatu UW.

The Chairman of the Doctoral Commission shall immediately forward to the Chairman of the RND a resolution
regarding the awarding of the doctoral degree together with the justification and protocol of the meeting
or about refusal to award the doctoral degree.

RND makes a decision in the form of a resolution to grant or refuse* a doctoral degree.

*Within 30 days of the date of delivery of the decision, the candidate may submit an appeal against the decision to refuse
to the Council of Scientific Excellence through the RND.

If you do not allow a dissertation to be defended or a decision to refuse to grant a doctoral degree is issued,
the same doctoral dissertation cannot be the basis for re-applying for a doctoral degree.
